Township Board Meeting, August 10, 2021 Minutes

Meeting at the Township Hall called to order at 6:30 PM, by Supervisor Blake-Thomas. The Pledge of Allegiance to the Flag and Roll Call of Board Members David Blake-Thomas, David Hillman, Joseph Boudreau. and Gary Loomis, Laura Simpson present. A quorum of the Township Board was in attendance.

Motion made by Supervisor Blake-Thomas to approve the meeting minutes of July 13, 2021 general meeting as written. Second Trustee Simpson Voice vote: All yes with no 'Nay' votes. Motion carried unanimously.

Board Comment:

Special Guests:

- Toni Phillips, Chippewa-Luce-Mackinac Community Action Agency presented senior meal program opportunities that could be introduced to the Trout Lake community. Motion made by Supervisor Blake-Thomas to approve sending a letter expressing our desire to open the Township Hall as a congregate center. Second Treasurer Boudreau Voice vote: All yes with no 'Nay' votes. Motion carried unanimously.

- 7. **Motion** made by Supervisor Blake-Thomas to approve the purchase of 4 new tires for the tanker. Second Treasurer Boudreau Voice vote: All yes with no 'Nay' votes. **Motion carried unanimously**.
- 8. Check the DNR website for burn advisories as the conditions continue to be dry
- 9. Call John Clark at 906-203-0621 if interested in joining the Fire Department

Ambulance Report:

- 1. One emergency call in the last month
- 2. St Ignace EMS Council is moving forward with the purchase of a new ambulance, power load system and cot. Five of the six council members have approved the purchase
- 3. New ambulance station. EMS Council is retaining an architect to draw up new building plans. Payment for the plans is anticipated to be from this year services profits.

Old Business:

Graymont grant for purchase of pickup truck \$17,750 received. Motion made by Supervisor Blake-Thomas to approve the purchase of a new Fire Department pickup truck not to exceed \$30,000. Second Clerk Hillman Roll call vote: Treasurer Boudreau yes, Trustee Simpson yes, Trustee Loomis yes, Supervisor Blake-Thomas yes, Clerk Hillman yes. All 'Yea' with no 'Nay' votes. Motion carried unanimously.

New Business:

- 1. **Motion** made by Supervisor Blake-Thomas to approve the Annual Tax Levy Resolution Trout Lake Township as presented in the amounts of 1.5835 operating and .65 debt retirement (town hall) Second Treasurer Boudreau Hillman **Roll call vote**: Supervisor Blake-Thomas yes, Trustee Loomis yes, Trustee Simpson yes, Treasurer Boudreau yes, Clerk Hillman yes. All 'Yea' with no 'Nay' votes. **Motion carried unanimously**.
- 2. Town Hall parking lot repairs. One estimate presented for simply filling the cracks. One estimate to fill the cracks and do a total resurface sealing. **Motion** made by Treasurer Boudreau to retain Mark Beaudoin to fill the cracks, resurface the entire parking lot, and repaint the lines at a cost of \$3700. Second Trustee Loomis Voice vote: All yes with no 'Nay' votes. **Motion carried unanimously**.
- 3. Senior citizens dinner and other services need better communications and coordination. A letter will be sent to express interest in starting the senior dinner program. Word of mouth is encouraged in passing of information on this and other subjects of interest in advance of a better communication tool.
- 4. **Motion** by Treasurer Boudreau to send a letter of appreciation to Sandy and Paul Chaney for the transfer of Christ Church to the township. Second Supervisor Blake-Thomas Voice vote: All yes with no Nay' votes. **Motion carried unanimously**.

Motion made by Supervisor Blake-Thomas to pay the bills as submitted by Clerk Hillman. Second Treasurer Boudreau. Motion approved unanimously by the Board Members in attendance with a voice vote.

Motion made by Supervisor Blake-Thomas to adjourn. Second Trustee Loomis. Voice approved. Meeting adjourned at 7:44 PM.
