- 2. Last day to pay winter taxes at the Hall will be February 28, 2025. Treasurer will be in the Hall on Tuesday December 31, 2024 from 9 am to 5 pm to collect taxes.

- 1. No runs for the month and the NFIRS Fire Report was entered for the month. NFIRS will be replaced with NERIS (National Emergency Response Incident System) by January 2026.
- The Argo has been delivered and training will be scheduled.

- 4. Tracks are being installed on the Ranger to support emergencies during the snowmobile season.

3. Grants from the Sault Tribe have been received. The Trout Lake Historical Society was awarded \$2205.00 and the Township was awarded \$14,577.90 for the construction of a 126 ft fishing pier near the boat launch in the campground. The Trout Lake IGA has also donated \$1,500.00 toward the project. The total cost of the pier will be approximately \$30,000.00 and will be funded from the Campground reserve funds (less grant and donation monies). The pier will be handicap accessible, hand rail on one side with an eighteen ft Tee at the lake end. **Motion** made by Supervisor Blake-Thomas and Seconded by Trustee Manshum to purchase the pier from Pier d'Nort. Voice vote: All 'yes' and no 'nay' votes. **Motion passed unanimously.** 

#### **New Business:**

1. **Motion** made by Supervisor Blake-Thomas and Seconded by Treasurer Ellis to adopt the 2025 meeting schedule, second Tuesday of each month and 6:30 pm. Voice vote: All 'yes' with no 'nay' votes. **Motion passed unanimously**.

 Motion by Supervisor Blake-Thomas and Seconded by Clerk Loomis to appoint Crystal Schwesinger, John Simaz and Jeff Sindles to the Board of Review for two years. Voice

vote: All 'yes' with no 'nay' votes. Motion passed unanimously.

3. **Motion** made by Supervisor Blake-Thomas and Seconded by Trustee Simpson to keep John Clark and the Township Fire Chief. Voice vote: All 'yes' and no 'nay' votes. **Motion** passed unanimously.

4. **Motion** made by Supervisor Blake-Thomas and Seconded by Treasurer Ellis to keep Supervisor Blake-Thomas as our representative on the Straits Area EMS board. Voice

vote: All 'yes' and no 'nay' votes. Motion passed unanimously.

5. **Motion** made by Supervisor Blake -Thomas and Seconded by Trustee Simpson to assign the position of FOIA Officer to Clerk Loomis. Voice Vote: All 'yes' and no 'nay' votes. **Motion passed unanimously.** 

 The assignment of non-statutory duties was made making Supervisor Blake-Thomas Campground Manager and Clerk Loomis Township Hall Manager and Cemetery Manager.

7. **Motion** made by Supervisor Blake-Thomas and Seconded by Trustee Simpson to hire Crystal Schwesinger to clean the Township Hall replacing Gary and Loretta Loomis. Voice Vote: All 'yes' and no 'nay' votes. **Motion passed unanimously.**

- 2. The Pride group stated that they had spent \$900.00 for Christmas gifts for the children of Trout Lake.

### **Board Comments:**

1. Trustee Simpson requested that the board confirm their intent to continue keeping the Christ Chapel available to the Historical Society. The Board stated that they had no intention of using the facility for anything else.
