Township Board Meeting, February 8, 2022 Minutes

Attendance: 16

Meeting at the Township Hall called to order at 6:30 PM, by Supervisor Blake-Thomas. The Pledge of Allegiance to the Flag and Roll Call of Board Members David Blake-Thomas, Joseph Boudreau, Gary Loomis, Laura Simpson and David Hillman present. A quorum of the Township Board was in attendance.

1. **Motion** by Treasurer Boudreau to approve the general meeting minutes January 11, 2022 as written. Second Trustee Simpson Voice vote: All yes with no 'Nay' votes. **Motion carried unanimously**.

#### **Public Comments:**

- Condolences to Deb Baker on the loss caused by fire. Thanks to community members Dave Blake-Thomas, Stefanie Clark, Jeff Waybrant, Cari Fischer, Mary Sharp, Shelly McGowan, Border Patrol, Chippewa County Sheriff, Hulbert Fire Department, Straits EMS, and Trout Lake Township Fire Department for their support during this traumatic event.

- 6. **Motion** by Trustee Simpson to accept the Fire Chief report. Second Trustee Loomis Voice vote: All yes with no 'Nay' votes. **Motion carried unanimously**.

## Ambulance Report:

- 1. Two ambulance runs to Trout Lake this month.
- 2. St. Ignace Area Council will disband and St. Ignace Area EMS Authority to be formed to take over.
- 3. EMS Authority may in the future request a millage to collect funds specifically for operation expenses in lieu of contributions from the member communities.
- 4. Ground breaking for the new ambulance building is anticipated for early spring.
- 5. **Motion** by Treasurer Boudreau to accept the Ambulance Report. Second Trustee Simpson Voice vote: All yes with no 'Nay' votes. **Motion carried unanimously**.

#### Old Business:

1. Trout Lake Historical Society is in the organization phase. Anyone wishing to contribute is encouraged to contact Loretta Loomis.

#### **New Business:**

- 1. Assessor contract renewal was considered. **Motion** by Supervisor Blake-Thomas to renew the current contract with amendments to include (1) mandatory 2 office hours per month at the Township Hall at published predetermined times (2) an automatic renewal provision for a one year extension with a 90 day termination notice provision (3) assessor is encouraged to attend Township Board meetings or notify absence in advance. Second Clerk Hillman. Roll call vote: Supervisor Blake-Thomas Yes, Treasurer Boudreau Yes, Trustee Loomis Yes, Trustee Simpson Yes and Clerk Hillman Yes. All yes with no 'Nay' votes. **Motion carried unanimously**.
- 2. FY 2022 budget. Increasing the line item for the EMS budget from \$10,000 to \$20,000 to adjust for the new ambulance contribution in addition to the annual fee. **Motion** by Supervisor Blake-Thomas to amend the EMS budget. Second Trustee Loomis: Voice vote: All yes with no 'Nay' votes. **Motion carried unanimously**.
- 3. FY 2022 budget. Increasing Town Hall maintenance budget from \$2000 to \$6500 for hall parking lot paving and unanticipated mechanical repairs. **Motion** by Supervisor Blake-Thomas to amend the Town Hall maintenance budget. Second Trustee Simpson: Voice vote: All yes with no 'Nay' votes. **Motion carried unanimously**.
- 4. Fix the kitchen propane feed by eliminating the 125-gallon tank and plumb a new line to the 1000-gallon tank. **Motion** by Trustee Loomis to replace the propane feed line to the kitchen with anticipated cost of \$1000 and sell the smaller tank to offset the change cost. Work to be done in Spring 2022. Second Supervisor Blake-Thomas: Voice vote: All yes with no 'Nay' votes. **Motion carried unanimously**.

Motion made by Trustee Loomis to pay the bills as submitted by Clerk Hillman. Second Trustee Simpson. Motion approved unanimously by the Board Members in attendance with a voice vote.

Motion made by Supervisor Blake-Thomas to adjourn. Second Trustee Loomis. Voice approved. Meeting adjourned at 7:26 PM.
